#### 24/74 WELCOME

The Chair welcomed Mr Raikes and Ms Gouldbourne to the meeting.

#### 24/75 DECLARATION OF BUSINESS INTERESTS

There were no declarations of interests in relation to this meeting.

#### 24/76 PART 1

The purpose of this meeting was to inform trustees and outline the roles and responsibilities of both the Local Governing Board (LGB) of Range High School and the Trust Board of the SLT.

A paper copy of a PowerPoint presentation was given to each trustee (Appendix 1) and the following points were included in the document and highlighted at the meeting:

- The responsibilities of the LGB
- At present all LGB Chairs are also trustees (part of the Trust Board), although it is recognised that this approach is contrary to the preference of the DfE and will become untenable as the Trust continues to grow. From September 2024 a Chairs Council will run alongside the Trust Board with a view to streamlining the Board from September 2025.
- The Trust Board is currently looking to appoint a further two trustees from across all member schools to the Board and anyone interested should speak to Mr McGarry.
- The LGB should meet six times per year (as at present) approximately two weeks before the Trust Board meet
- It was acknowledged that, to attend all the LGB meetings, Chairs Council and Trust Board meetings, requires a huge commitment, especially from the Chair of the LGB
- Range High School's current Articles of Association will cease to be relevant and the SLT's Articles of Association will replace them from 1 September 2024.

Q. Can trustees continue on the LGB with their current term of office end date? Or, can they be appointed for a further 4-year term from 1 September 2024?

A. Either of those options are possible. The Trust recommends at least two Parent governors should be on the LGB. The LGB would be made up of Parents, Staff and Co-opted members.

Mr Raikes, Ms Gouldbourne and Mrs Phillips left the meeting.

There was discussion regarding whether current trustees of Range High School would opt to stay on the LGB after 1 September 2024. The following table shows the outcome of those discussions:
